### **Admission tests**

The application must be accompanied by an original research project relating to the area of legal sciences, with a length of between 10,000 and 20,000 characters, and accompanied by an adequate bibliographic apparatus. In the title page of the research project, the candidate must indicate the curriculum for which he intends to compete, the title and the scientific-disciplinary sector of reference of the project. The candidate can draw up the research project and ask to sit the oral exam, instead of in Italian, in English, French or Spanish.

The commission first of all determines the evaluation criteria, adhering to the following indications regarding the elements that can be evaluated and the attribution of points.

- a) For the evaluation of the project and qualifications: maximum 60 points, of which
- at least 35 points assigned to the evaluation of the research project





- no more than 5 points for the degree mark if equal to or greater than 105/110, appropriately articulated both on the basis of the score achieved and on the basis of the assignment or not of honors
- no more than 2 points for any letters of introduction from university professors of legal subjects on tenure or on leave;
- no more than 5 points for the possession of the title of expert on the subject in examination committees relating to legal disciplines
- no more than 10 points for any legal publications published in scientific journals or volumes published by leading publishing houses
- no more than 5 points for the achievement of prizes for degree theses or publications
- no more than 5 points for documented research stays at qualified universities or research institutions abroad.

### Candidates who have achieved a minimum of 36 points are admitted to the oral exam.

b) For the oral exam: maximum 60 points, of which no more than 10 for knowledge of the foreign language.

The oral exam is aimed at demonstrating a good interdisciplinary legal culture, starting from the subject matter of the research project, as well as adequate knowledge of the language chosen by the candidate, other than the one in which the interview was taken.

At the end of the oral exam, the commission draws up two distinct rankings (one reserved for graduates from Mexican universities with a research project on human rights, the other for the remaining candidates), in which all the candidates who have obtained at least 72 points.

In the event of lack of suitable candidates in the list reserved for graduates of the Universidad de Coahuila with a human rights project, the scholarship will not be awarded.

The calendar of tests will be made known exclusively by publication on the website www.unifg.it as well as by posting in the University Telematic Register. This publication has the value of notification for all legal purposes and will take place at least 20 days before the date established for the performance of the test.

### Course description and objectives

The Doctorate in "Legal Sciences" intends to develop a multidisciplinary cognitive path of the evolutionary dynamics of Western legal systems, and European ones in particular, in the transition from their traditional reference contexts to those that are emerging in the scenarios of globalized post-modernity. The goal of training jurists aware of these changes and capable of facing the challenges in both theoretical and practical fields, is pursued through two curricular paths, methodologically rather than thematically distinct: "Persons and rights in the global market"; "Identity and diversity in legal experiences".

The first curriculum looks at the person and the market as characteristic phenomena of the present, considering the ways of interaction and possible compatibility, from an interdisciplinary perspective, critically re-reading the lines of development of living law and the possible ways of its concrete (and not only legislative) evolution. The second curriculum aims to provide critical understanding of our legal identity, also through the comparison with different scenarios, in time and space, with particular attention to certain long-term polarities (law or jurist law; civil law and common law, private law and public law; national law and supranational law).





The joint training activities will allow PhD students to compare the two different approaches, enriching their respective knowledge and experiences.

### Job and career opportunities

Given that the Doctorate aims to train scholars capable of moving easily in the new global law and to prepare highly qualified researchers who correspond to the needs of the world of legal professions, that of business and institutions, the professional opportunities envisaged will be above all in the "area of top positions - which require high expertise in the legal field - in the University, in professional firms and in public and private bodies, nationally and internationally. The training activities provided during the three-year period will also allow PhDs to acquire the necessary skills to be able to deal with the legal problems relating to Big Data in the various contexts in which they will be called to operate.

# **Training activity description**

Language lessons	There are transversal courses, common to all doctorates activated in the university, for the deepening of the English language. In particular, online courses are also activated, through the University Language Center, on the proprietary E-LEARNING platform, for the acquisition of language skills, as well as specific courses on writing and public communication.
Computer lessons	Transversal courses and laboratory activities are organized at the affiliated universities, common to all the doctorates activated in the university, relating to the in-depth study of IT tools. In particular, online courses are activated, on the proprietary E-LEARNING platform, for the acquisition of skills relating to information technology and telematics and digitization.
Research management, knowledge of the research system and funding agreement	The University of Siena organizes transversal basic training modules on the topics of research management, in order to facilitate the acquisition of the complementary skills required at European level, including issues relating to the management and transfer of big data.
