**Object:** *Approval of competition documents for admission to the Doctoral in "Economics and Finance of territorial sustainability and well-being" (XXXVIII cycle a.y. 2022/2023).*

## THE RECTOR

**GIVEN** the law n. 210 of 3 July 1998, in particular art. 4, containing rules on research doctorates;

**GIVEN** the law n. 240 of 30 December 2010 and, in particular, Article 19; Given the Ministerial Decree no. 226 of 14 December 2021 containing the "Regulations containing the methods of accreditation of the sites and of the Doctoral Courses and criteria for the establishment of the Doctoral Courses by the accredited bodies";

**GIVEN** the University Research Doctorate Regulations;

**GIVEN** the Ministerial Decrees n. 351 and 352 of 9 April 2022;

**GIVEN** the announcement approved with the Rector's Decree n. 1288-2022, prot. n. 37842-111 / 6 of 15 July 2022, with which, for the academic year 2022/2023, the public selection for admission to the PhD courses relating to the XXXVIII cycle was announced, with administrative headquarters at this University and the relative notice, published in the Official Gazette 4th Special Series - Competitions and Exams, n. 62 of 08/05/2022;

**NOTED** that the explanatory sheet was attached to the aforementioned call, indicating the number of position in the research doctorate in "Economics and Finance of territorial sustainability and well-being" (Annex D sheet);

**GIVEN** the Rector's Decree n. 1489/2022, prot. n. 43625-III/6, del 05/09/2022, date with which the examining commission for the admission competition to the above-mentioned Research Doctorate was appointed;

**CONSIDERED** that the examination tests for the admission competition referred to in the subject have been duly completed;

**ACKNOWLEDGED** the formal regularity of the procedure and related documents;

## DECREES

### Article 1

- to approve the acts of the public selection, based on qualifications, research project and oral exam, for admission to the PhD Course in "*Economics and Finance of territorial sustainability and well-being*" with administrative headquarters at the University of Foggia, cycle XXXVIII, Academic Year 2022/2023, announced with the D.R. n. 1288/2022 prot. n. 37842-III / 6 of 15/07/2022, referred to in the introduction;

### Article 2

- to approve the general ranking of merit for the PhD course in "*Economics and Finance of territorial sustainability and well-being*" reported in attachment no. 1, as an integral part of this decree, subject to the verification of the possession by the candidates of the requirements for admission to the selection and the truthfulness of the declarations made through self-certification;

### Article 3



- to admit, according the available doctoral post and the merit rankings listed in the previous article, to the PhD in “*Economics and Finance of territorial sustainability and well-being*” with administrative headquarters at the University of Foggia, cycle XXXVIII, a.y.2022/2023 on positions with ordinary scholarship and on eligible positions, within the resources ex D.M. n. 351 and 352 of 9 April 2022, after verification of eligibility for PNRR support, carried out by the Ministry, of the selected and assigned scholarship, on the basis of the eligibility requirements identified in Articles 6, 7, 8 and 9 of the Ministerial Decree 351/2022 and art. 6, paragraph 3 and paragraph 4, of Ministerial Decree 352/2022, the candidates listed below:
