## DECREES

### Article 1

### Article 2

### Article 3

- to approve the general ranking of merit for the PhD course in "Learning Sciences and Digital Technologies" reported in attachment no. 1, as an integral part of this decree, subject to the verification of the possession by the candidates of the requirements for admission to the selection and the truthfulness of the declarations made through self-certification;

### Article 4

- to admit, according to the available doctoral post and the merit rankings listed in the previous article, to the PhD in Learning Sciences and Digital Technologies with administrative headquarters at the University of Foggia, cycle XXXVIII, a.y.2022/2023 on positions with ordinary scholarship and on eligible positions, within the resources ex D.M. n. 351 and 352 of 9 April 2022, after verification of eligibility for PNRR support, carried out by the Ministry, of the selected and assigned scholarship, on the basis of the eligibility requirements identified in Articles 6, 7, 8 and 9 of the Ministerial Decree 351/2022 and art. 6, paragraph 3 and paragraph 4, of Ministerial Decree 352/2022, the candidates listed in attachment no. 1;

### Articolo 5
