THE RECTOR

- GIVEN** the law 13/08/1984, n. 476, attesting regulations on matters regarding scholarships and doctoral course and subsequent amendments and additions;
- GIVEN** the law 30/11/1989, n. 398, and subsequent amendments and additions;
- GIVEN** clause 4 regarding the law 3/7/1998, n. 210, modified from the article 19 of the law 30/12/2010 n. 240;
- GIVEN** the Inter-ministerial Regulation (ministerial decree) 9/7/2009, that determines the conformity between the "Diploma di laurea (DL) – five year degree", "Lauree Specialistiche (LS) ex ministerial decree 509/1999 – Postgraduate degrees" and "Lauree Magistrali (LM) ex ministerial decree 270/2004 – master's degree";
- GIVEN** the current University of Foggia Statute;
- GIVEN** the legislative decree 11th April 2006, n.198 "Equal Opportunity Code between Men and Women";
- GIVEN** the Regulations of the University of Foggia on PhDs, issued by D.R. No.1651 of 03 October 2022;
- GIVEN** art. 1 paragraph 254 and following the Stability Law 2017 (L. n. 232/2016);
- GIVEN** the University regulation approved with the D.R. 599/2022 prot.n. 18478-I/3 of the 5th April 2022 regarding taxes and contributions matters;
- GIVEN** the ministerial decree n. 226, 14th December 2021 with which the "Regulations attesting the modality of location accreditation and doctoral courses and the criteria for the institution of doctoral courses belonging to accredited institutions", that has substituted the previous ministerial decree of the 8th February 2013 n. 45;
- GIVEN** the ministerial decree n. 247 23 February 2022 with which the ministerial decree 25th January 2019 has been modified, n. 40 regarding the annual total sum of the doctoral courses scholarships that takes effect from the 01/07/2022, from € 15.343,28 to € 16.243,00 (gross from the social security contributions which are charged to the addressee);
- GIVEN** the ministerial decree 9th April 2022, n. 351 which attests the conferment of doctoral courses scholarships basing on the PNRR, Mission 4, component 1, "Development of the choice of education services: from Nursery schools



	to university” – Investment 3.4 “Didactics and advanced university competences” and Investment 4.1 “Extension of the number of Doctoral courses and innovative doctoral courses for the public administration and cultural heritage”, under which the University of Foggia proved to be recipient of n. 18 funding destined to doctoral course scholarships for the “PNRR” macro areas, “Digital and environmental transitions”, “Public Administration” and “Cultural Heritage”;
GIVEN	the ministerial decree 9th April 2022, n. 352 which attests the attribution of doctoral course scholarships based on the PNRR, Mission 4, component 2 “From research to business” – Investment 3.3 “Introduction of innovative doctorates that satisfy the requests for business innovation and promotes the employment of researchers from companies”, under which the University of Foggia has proved to be recipient of ministerial co funding of n.31 scholarships for doctoral courses in the sector of innovative doctoral courses which satisfy the requests of business innovation;
GIVEN	the approved Document by the President of the board of directors of ANVUR relative to the accreditation of PhD courses;
GIVEN	the approval by the Academic Senate, on an extraordinary session 23/05/2022, of the request of accreditation of PhD courses presented for the XXXVIII cycle (specified in the following) and the assignment of the PhD course scholarships for the following; <ul style="list-style-type: none">- Basic and Clinical Neuroscience;- Biotechnology and Smart Practices for a sustainable Management of Natural Resources, Food and Agriculture;- Law and Safety;- Economics and Finance of Territorial Sustainability and well being;- Learning Sciences and Digital Technologies;- Educational, Development and Learning Science;- Innovative Science and Technologies for health and active aging;- Economics;- Human science;
GIVEN	the approval by the board of directors during the extraordinary session on the 23/05/2022, for the accreditation request of the former PhD courses presented for the XXXVIII cycle and the assignment of PhD scholarships;
GIVEN	the letters of intent and conventions between University of Foggia and institutions and private companies to activate and finance or co-finance the doctoral course scholarships for the XXXVIII cycle also in accordance with the ministerial decree 352/2022;
GIVEN	the agreements with University of Foggia regarding inter-university courses;
GIVEN	the agreements with other Italian universities regarding the national doctoral course in Learning Sciences and Digital Technologies for which University of Foggia is the administrative headquarters;
VERIFIED	that for the scholarships presented in the competition there is also financial coverage;
CONSIDERED	that possible modifications and/or integrations on the following announcement will be published exclusively on the Albo Ufficiale di Ateneo



- (Official University Notice Board) and on the university website in the section "PhD - XXXVIII ciclo";
- EXPECTED** that in accordance to the decree MUR n. 226 of 14/12/2021, the PhD courses can be activated only prior accreditation granted from the Ministry, and the assent of the ANVUR;
- ACKNOWLEDGED** the positive outcome for the accreditation assessment of the ANVUR, published on the platform CINECA, regarding the aforementioned PhD courses for which University of Foggia is the administrative headquarters;
- GIVEN** the Rector's Decree n. 1288 of 15/07/2022 with which the "SELECTION NOTICE FOR ADMISSION TO DOCTORAL COURSES XXXVIII CYCLE - UNIVERSITY OF FOGGIA A.Y. 2022/2023" was issued aimed at banning public competitions for admission to the nine above-mentioned and accredited PhD courses;
- CONSIDERED** that the specific characteristics of the individual PhD courses (available position, specific characteristics of the aforementioned Courses, type of qualifications required for participation in the competition, any additional requirements and admission procedures) have been detailed in nine Sheets attached to the Call being an integral part of it;
- EXPECTED** that Sheet E specifies the characteristics of the PhD course of national interest in Learning Science and Digital Technologies with administrative headquarters at the University of Foggia;
- GIVEN** the Rector's Decrees No. 1492/2022 and 1530/2022 relating, respectively, to the appointment and subsequent integration of the selection board for the selections for admission to the doctoral course in Learning Sciences and Digital Technologies;
- GIVEN** the Rector's Decree n. 1649/2022 with which the acts of the selections and the relative merit rankings for admission to the aforementioned PhD course were approved;
- CONSIDERED** that at the conclusion of the selection procedures were assigned no. 88 PhD positions of which n. 66 with scholarship and n. 22 without scholarship;
- EXPECTED** that from the updating of the agreements stipulated with the associated universities, result in deeds no. 91 doctoral positions for the PhD in question and, specifically, n. 69 positions with scholarship and n. 22 positions without scholarship;
- ACKNOWLEDGED** that in the CINECA platform dedicated to PhD courses there are unassigned no. 3 positions with scholarship funded with PNRR funds and, in particular:
- University of Calabria: No. 1 position with scholarship funded by Ministerial Decree No. 351/22 – within the scope of: Public Administration;
 - Polytechnic University of Marche: No. 1 position with scholarship funded by Ministerial Decree No. 351/2022 – within the scope of: PNRR;
 - Universitas Mercatorum Online University: No. 1 position with scholarship funded by Ministerial Decree No. 351/2022 – within the scope of: PNRR;



GIVEN	the request submitted by the coordinator of the PhD course in Learning Sciences and Digital Technologies aimed at reactivating the selection procedure on the remaining vacant positions;
EXPECTED	the lack of eligible candidates in the final merit ranking and therefore the impossibility of scrolling it;
EXPECTED	that, in the event of non-enrollment of the candidates listed in the merit ranking, further places with a grant financed with PNRR resources may not be assigned;
CONSIDERED	that significant interest is the assignment of all position in the PhD course of National Interest with administrative headquarters at the University of Foggia in Learning Sciences and Digital Technologies and in particular of the position with scholarship funded by PNRR resources;
REPUTED	appropriate, exclusively for the PhD course of national interest in Learning Sciences and Digital Technologies, to reopen the period for the "NOTICE OF COMPETITION FOR ADMISSION TO THE DOCTORATE OF RESEARCH XXXVIII CYCLE - UNIVERSITY OF FOGGIA A.A. 2022/2023", for the three unassigned places and for any non-enrollment of those admitted to the final merit ranking;

Art. 1

Reopening of terms

The period for the public selection notice issued with Rector's Decree n. 1288 of 15/07/2022, are reopened for the assignment of **no. 3 positions with scholarship** for the PhD course of national interest with administrative headquarters at the University of Foggia in "Learning Sciences and Digital Technologies" - XXXVIII cycle - a.y. 2022/2023, specified below:

- University of Calabria: No. 1 position with scholarship funded by Ministerial Decree No. 351/22 – within the scope of: Public Administration;
- Polytechnic University of Marche: No. 1 position with scholarship funded by Ministerial Decree No. 351/2022 – within the scope of: PNRR;
- Universitas Mercatorum Online University: No. 1 position with scholarship funded by Ministerial Decree No. 351/2022 – within the scope of: PNRR.

Art. 2

Admission request

The submission of the application for admission to the selection in question must be submitted only through digital procedure within the peremptory deadline of 11/10/2022, and not after 12.00 (Italian time), through the Esse3 portal of the University of Foggia by clicking the following website <https://unifg.esse3.cineca.it/Home.do>

The participation requirements, the procedures for registering for the competition and the documents to be included in the platform are indicated, respectively, in art. 2 and in art. 3 of the D.R. n. 1288/2022.



Art. 3

Admission Assessment

The admission assessment consists in an adequate comparative valuation to guarantee the eligibility and the inclination of the candidates towards the scientific research. The admission will be conducted by assessing:

- Titles (publications, curriculum vitae etc.);
- Assessment of the "research project" proposed (the research project must be attached to the application and written in compliance with the format appendix No. 1);
- Oral Test regarding the PhD courses subjects and an English language assessment to verify the knowledge; each candidate can request also to take the oral test completely in English.

The interviews will take place on 18th October 2022.

Art. 4

Selection Board

The selection board remains confirmed the one appointed for the selection and subsequently integrated by Rector's Decrees No. 1492/2022 and No.1530/2022, as well as are confirmed all the fulfilments foreseen in the original selection announcement not modified by this provision.

Art. 5

Scholarships

Without prejudice to the provisions of art. 9 "Scholarships" of the D.R. n. 1288/2022, based on the new University Regulations for PhD programs, approved by D.R. n. 1651/2022 of 03/10/2022, "the scholarship is paid exclusively to doctoral students who have an annual taxable income not exceeding the annual amount of the scholarship (€ 16,243.00).

All candidates are admitted to the course with reserve until all the declarations have been verified in accordance to the Presidential Decree 445/2000 and following.

Art. 6

Final Provisions
