## **DECREES**

# Article 1

- to approve the acts of the public selection, based on qualifications, research project and oral exam, for admission to the PhD Course in "Economic Sciences" with administrative headquarters at the University of Foggia, cycle XXXVIII, Academic Year 2022/2023, announced with the D.R. n. 1288/2022 prot. n. 37842-III / 6 of 15/07/2022, referred to in the introduction;

### Article 2
