General Provisions

- Given that cultural and scientific exchange is indispensable to academic and social institutions to develop their educational and research activities;
- given that, for the above-stated purpose, it is necessary to promote and encourage direct cultural agreements between institutions of higher learning at European and International level;
- having verified the mutual interest that the Università di Foggia and ROADPOL e.V. – European Roads Policing Network of share in establishing an appropriate form of common educational programs in the field of:
 - a) Police Cooperation;
 - b) Road Safety;
 - c) European partnership
- in agreement with the laws applicable to the two parties and, as far as the Italian law is concerned, with Ministerial Decree of october, 22 2004 n. 270 concerning forms of educational autonomy of individual universities.

THE FOLLOWING TERMS OF AGREEMENT ARE STIPULATED

ART. 1

As to the successful realization of the Agreement, Università di Foggia and ROADPOL – European Roads Policing Network agree to the following terms of exchange subject to the availability of appropriate resources and the agreement of collaborating academic department:

- a) circulation of publications and information on the specific fields of study and research, included in this agreement and on any other subject of relevant interest;
- b) organisation of Joint Degree Courses, High Education Courses, Masters and possible specific Classes;
- c) organisation of joint scientific conferences and workshops;
- d) exchange of publications, university editions, books and co-operation in communication networks;
- e) joint design and implementation of research projects.



Università di Foggia and ROADPOL – European Roads Policing Network subscribing this agreement intend to follow specific criteria of reciprocity.

ART. 2

Università di Foggia and ROADPOL – European Roads Policing Network subscribing this agreement will exchange all relevant information - by supplying catalogues and other materials - to promote greater and mutual knowledge on their institutional structure and organization.

ART. 3

Each of the subscribing parties commits itself, through its participating units, to search funds to carry out the activities foreseen by this agreement.

Università di Foggia and ROADPOL – European Roads Policing Network should make joint applications to the EU institutions and organisations for research grants and funds available in the mutually defined fields and topics where collaborative links are established.

ART. 4

Any article of this Agreement may be amended or revoked after consultation and mutual consent between Università di Foggia and ROADPOL – European Roads Policing Network.

ART. 5

This Agreement is concluded for an initial duration of 3 (three) years from the date of joint signing. After this period this Agreement can be re-examined if deemed necessary. After 3 (three) years, the Agreement shall be renewed for another 3 (three) period, unless terminated by one of the parties by written notice three months prior to the expiration date.

ART. 6

The implementation of the activities foreseen by the agreement will be promoted, initially, by the following Coordinators, appointed by each party:

Should any disputes arise, the problem will be entrusted to a board of arbiters made of one member selected by each partner and one chosen by common consent.
