Topics: Cultures of Sustainability and Organized Crime in the Gargano area: An Anthropological Analysis

Research activity:

The project takes an ethnographic approach to analyse how crime and the culture of sustainability affect the social and economic fabric of the Gargano area. The research will focus on how criminal activities impact community dynamics, social relations, and local economic development, as well as how public and private entities in the area practice socio-economic and environmental sustainability. Through ethnographic investigation and field interviews, the focus is on the understanding how the local population perceives and responds to crime and sustainability, as well as the strategies implemented for resilience and adaptation.

The goal is to gain a deep understanding of the challenges related to crime and sustainability in the Gargano area, as well as to identify potential solutions to build social and economic resources. This project also seeks to improve safety and prosperity for local communities. Additionally, it aims to support Puglia's Smart Specialization Strategies and Regional Sustainable Development Strategies by focusing on including the most vulnerable social groups and promoting social sustainability based on social rights. Through using existing research practices, the project will assist stakeholders and policy makers in assessing the impact of social inclusion and developing effective approaches to strengthen community capabilities. Participatory dissemination and communication initiatives will be used to promote these practices, with the goal of creating sustainable and inclusive towns and cities, increasing heritage awareness, and encouraging citizen involvement in the region's inner areas.

Topics: The socio-economic impact of Italian national parks on local communities

Research activity:

National parks offer a significant opportunity to protect land, natural resources, and promote sustainability. Recently, the Ministry of the Environment and Energy Security has emphasized that these can also drive economic development beyond just supporting tourism activities. However, these opportunities have not been fully caught by our country's national park system. In today's economy, the most significant value of natural resources and recreational opportunities often lies in the ability of protected areas to attract and retain residents, entrepreneurs, businesses, and citizens (e.g. retirees, remote workers, etc.) seeking better quality of life. The research project's goal is to assess the growth stimulated by national parks using a multidisciplinary approach. This entails evaluating both the economic impacts on local communities and identifying future opportunities that have not yet been tapped into, as well as any development constraints.
