Eligibility criteria

Young researchers who have completed their doctoral studies, having spent a period of training and research abroad of at least 3 months and who are up to 40 years old on the date of publication of the report, or for profiles aged over 40 and up to 45 years, have completed their PhD for a maximum of 7 years, and are in one or more of the following conditions:

- have gained initial experience as a manager of funds and/or research activities;
- have experience in leading and managing a national and/or international research team;
- not have, or have not had a full-time equivalent (FTE) contract for an indefinite period as a researcher and/or professor.

The application for participation must contain, under penalty of exclusion, the description of the project proposal that the candidate proposes to carry out within the research program indicated within the art. 1.

The application, with its attachments, must be sent in a single file in a readable format with the following subject-matter: Application n. 1 Post-doctoral research contract S.S.D.GIUR-03/A_SURNAME and FIRST NAME of the candidate.

Under penalty of exclusion, the application for participation in the above mentioned selection, drawn up according to the template attached to this call, must be signed by the candidate and accompanied by the following documents:

photocopy of a valid identity document;

curriculum of their scientific and professional activity, as well as the qualifications held. The curriculum, duly dated and signed, must contain the self-declaration, pursuant to art. 46 and 47 of Presidential Decree 445/2000, certifying the truthfulness of the information contained therein;

scientific publications, in the maximum number established by the previous article 1, which are deemed useful to present for the purpose of the selection procedure;

a replacement declaration of the notoriety statement certifying the conformity to the original for the publications submitted and listed in the declaration itself;

documents and qualifications that are considered useful for the purposes of the selection, provided with a replacement declaration of certification alternatively in a certified copy through a replacement declaration of the notoriety statement;

information and authorization for the processing of data, the which signature is necessary in order to submit the request to participate in this selection;

declaration given in regard to the lack of situations that would prevent the formalization of the relationship in the event of a positive outcome.

Candidates are admitted to the oral exam on condition of achieving a minimum score of 15 points.
