

NOTICE AND GUIDELINES FOR PHD ENROLMENT 41 CYCLE

IMPORTANT: THE REGISTRATION PROCEDURE REQUIRES THE UPLOAD OF DOCUMENTS. PLEASE ENSURE THAT YOU HAVE THEM AVAILABLE IN .PDF FORMAT AND THAT YOU HAVE SIGNED THEM BEFORE STARTING THE PROCEDURE

All candidates admitted to a Doctoral Course -41 Cycle (academic year 2025/2026) must complete the online enrolment process through the ESSE3 platform, within the deadlines established for each programme as specified in the official Notice published on the University bulletin board and on the webpages of the individual programmes.

GRADUATORY

On <u>Unifg.it</u>, n the section dedicated to the Doctorate 41 cycle, it is possible to view the rankings for access to each Doctoral Course announced by the University of Foggia.

REGISTRATION OF WINNERS

Registration can only be completed on the Esse3 platform, following the steps listed:

- Access the Esse3 platform, at the following link: https://unifg.esse3.cineca.it/Home.do, with the credentials already used to register for the competition;
- Click on REGISTRAR'S OFFICE → ENROLMENT → at the bottom of the page click on "IMMATRICOLAZIONE" → select "IMMATRICOLAZIONE STANDARD" → select "CORSO DI DOTTORATO (D.M. 226/2021)" → AVANTI
- Select the PhD Course in which you have been awarded → AVANTI → select the curriculum if the Course includes more than one → AVANTI
- Check that the summary contains all the correct data and then click on CONFERMA
- Select whether the Career is linked to dual enrolment (YES or NO)
- In the PA110 e lode section click on NO as PhD courses do not fall under the above-mentioned initiative → AVANTI → PROCEDI → PROCEDI
- If not entered during registration, upload your ID by clicking on "INSERISCI NUOVO DOCUMENTO DI IDENTITA" → PROSEGUI
- Insert a Declaration of disability (if in possession) by clicking on INSERISCI NUOVA DICHIARAZIONE DI INVALIDITA' → AVANTI
- Upload a photo ID → CONFERMA
- At the bottom of the page summarising your qualifications click on "PROCEDI" → in the "Stato occupazionale" section select "NON LAVORATORE, STUDENTE FULL TIME" from the drop-down menu → AVANTI → CONFERMA (Please Note: <u>This option must be selected regardless of your employment status</u>)
- Insert the documentation required for enrolment by clicking on "INSERISCI ALLEGATO" (for each document to be uploaded) using the forms downloadable from the site, in the 'IMMATRICOLAZIONE AL DOTTORATO DI RICERCA' section, at the following link: https://www.unifg.it/it/studiare/post-lauream/dottorati-di-ricerca/modulistica → AVANTI N.B. For PhD students WITH a scholarship, upload the REGISTRATION FORM WITH SCHOLARSHIP. For PhD students WITHOUT a scholarship, upload the REGISTRATION FORM WITHOUT a scholarship
- Proceed with the required payments through PagoPA.

ONLY For CANDIDATES ADMITTED WITHOUT a SCHOLARSHIP

- Re-access the admission phase of the <u>competition</u> from the SEGRETERIA → PROCEDURA DI AMMISSIONE → select AMMISSIONE AL DOTTORATO 41 CICLO IN ... (name of the course you are enrolled in) → at the bottom of the page click on "MODIFICA TITOLI DI VALUTAZIONE" → select YES to the question "Vuoi inserire documenti e/o titoli alla domanda di ammissione" → AVANTI
- In the TIPOLOGIA drop-down menu, select your income bracket (<u>Please Note: it is essential to make the correct choice since the correct calculation of the fees due depends on this</u>) → in the TITOLO section enter "AUTODICHIARAZIONE REDDITO" → upload the attached AUTODICHIARAZIONE REDDITO by entering the self-declaration of your income (always using the form that can be downloaded at the link https://www.unifg.it/it/studiare/post-lauream/dottorati-di-ricerca/modulistica)

All documents must be signed and uploaded in PDF format.

TAX

The cost of attending a PhD programme consists of three components, payable in two instalments, as follows:

- 1) Stamp duty € 16.00 all PhD candidates are required to pay the stamp duty;
- 2) Annual ADISU Regional Tax for the Right to Higher Education all PhD candidates are required to pay the ADISU regional tax. The amount of this tax is determined on the basis of the candidate's ISEEU value according to the following criteria:
 - a) First bracket: €144.00 for students whose ISEEU (Equivalent Economic Situation Indicator for university services) is less than or equal to €26,000.00;
 - b) Second bracket: €168.00 for students whose ISEEU is between €26,000.01 and €52,000.00;
 - c) Third bracket: €192.00 for students whose ISEEU is greater than €52,000.01.
 - The Regional Tax is paid in two instalments. At the time of enrolment, all students must pay the base amount corresponding to the first bracket, €144.00. Only those whose ISEEU exceeds € 26,000.01 will pay, in the second instalment, the difference between the first bracket amount (already paid at enrolment) and the amount corresponding to their own ISEEU bracket.
 - According to the ADISU Puglia Call for Benefits and Services, the student's economic condition is determined based on the **ISEEU** (Equivalent Economic Situation Indicator), which must include the **statement "Applicable to subsidised benefits for the right to university education**", and on the **ISPE** (Equivalent Patrimonial Situation Indicator).
 - NB: If a student is simultaneously enrolled in two degree programmes, both at universities located in the Apulia Region, they are required to pay only one ADISU regional tax for the right to higher education, equal to the amount corresponding to their ISEEU bracket.
- 3) Annual contribution for access to and attendance of PhD programmes. The amount of this contribution varies depending on whether or not the student receives a scholarship. Students who obtained their degree abroad are exempt from paying this contribution.

ANNUAL CONTRIBUTION AMOUNT - PHD CANDIDATES WITH SCHOLARSHIP

PhD candidates receiving a scholarship are required to pay an annual contribution for access to and attendance of PhD programmes amounting to €300.00, divided into two instalments:

- a) First instalment: payable at the time of enrolment/registration (€150.00);
- b) Second instalment: payable by 31 January (€150.00).

Therefore, the correct breakdown of the two instalments for PhD candidates with a scholarship is as follows:

The registration receipt must be printed and uploaded in Esse3 in the Career attachments section.

Students enrolled in another social security fund must indicate this explicitly in the enrolment form.

ANNUAL CONTRIBUTION AMOUNT - PHD CANDIDATES WITHOUT SCHOLARSHIP

PhD candidates without a scholarship are required to pay an annual contribution for access to and attendance of PhD programmes, the amount of which ranges from a minimum of \in 300.00 to a maximum of \in 800.00, depending on their income from self-employment or salaried work, according to the table below:

FULL/PARTIAL EXEMPTIONS applicable to PhD students with or without scholarship

Disabled doctoral students, with a disability <u>HIGHER OR EQUAL to 66%</u>, are totally exempt from the application ADISU Tax and the Annual Contribution, but not from stamp duty of € 16.00. Disabled doctoral students with a disability <u>RATIN BETWEEN 45% and 65%</u> are required to pay the Stamp duty, the ADISU registration fee, and the Annual Contribution reduced by 50%.

ELIGIBLE NON-WINNER

Candidates who are deemed ELIGIBLE non-winners in the Rectoral Decree of Approval of the Proceedings are not admitted to attend the PhD programme. However, in the event of any withdrawals by winners, the ranking lists will be updated according to the procedures and timelines set forth in Article 17, paragraphs 6 and 7, of the <u>University PhD Regulations</u>.

The PhD Office will notify the concerned candidates directly.

WITHDRAWAL

A candidate who, having been declared a winner of the competition, is unable to accept the type of position assigned (e.g., due to income limits) should not proceed with enrolment but must promptly notify the PhD Office (<u>ufficiodottorato@unifg.it</u>), requesting that their eligibility in the ranking be preserved for potential reallocation and/or any further available positions compatible with their conditions.

If such notification is not provided, winning candidates who do not complete enrolment within the established deadlines will be removed from the ranking list of the PhD programme (Article 11, paragraph 2 of the PhD Call for Admission).
