## 1. INTRODUCTION

The ECOFOODCYCLE project, funded under the Interreg Italy-Croatia 2021-2027 Programme, aims to contribute to the prevention and reduction of food waste across the Programme area by strengthening cross-border cooperation, improving knowledge and capacity among stakeholders, and promoting sustainable practices along the food supply chain.

The project brings together Italian and Croatian partners to develop shared methodologies, pilot innovative solutions, and test transferable approaches addressing food waste prevention, management, and awareness-raising. Particular attention is given to the involvement of key actors along the food supply chain, including the retail sector, as well as to end users, in order to foster responsible behaviours and more efficient food systems.

Within this framework, the University of Foggia (PP7) will implement a local pilot action in the Puglia Region (Italy). The pilot action will test an innovative and replicable approach to food waste reduction, contributing to the achievement of the project's objectives and to the development of concrete, practice-oriented solutions that may be scaled up or transferred to other contexts.

## 2. OBJECTIVE

The objective of this expression of interest is to identify a business from the large-scale retail sector interested in collaborating with the University of Foggia in the implementation of a local pilot action aimed at reducing food waste, in the framework of the ECOFOODCYCLE project.

The pilot action will serve as a testbed for an innovative and replicable approach to food waste prevention and awareness, promoting collaboration between the retail sector and the general public. The selected retail operator will play an active role in implementing the pilot, which will involve the recovery and repurposing of surplus food products close to expiry through the creation of thematic food boxes, made available to consumers via selected in-store points.

The initiative is expected to generate measurable outcomes, raise awareness, and contribute to behavioural change among end users, while highlighting the commitment of the retail sector to sustainability and food waste reduction.

The selected candidate will contribute to the co-design and operational implementation of the pilot, in coordination with the University of Foggia. For this reason, any additional ideas and suggestions regarding the refinement and implementation of the proposed concept for the pilot action will be considered as part of the evaluation process.

## 3. ELIGIBLE APPLICANTS



The target applicants for this expression of interest are businesses operating in the large-scale retail sector (GDO) in the Puglia Region (Italy), who are interested in collaborating with the University of Foggia in the implementation of the local pilot action under the ECOFOODCYCLE project.

In order to be eligible, applicants must meet the following criteria at the time of submission:

- Be a legally constituted company, duly registered with a Chamber of Commerce;
- Operate in the large-scale retail distribution sector;
- Have a registered office and/or an operational unit located in the Puglia Region (Italy);
- Not be subject to bankruptcy, liquidation, receivership, or any equivalent procedure under applicable laws.

#### **4. LOCATION AND IMPLEMENTATION PERIOD OF THE ACTIVITY**

The pilot actions will take place in the Foggia area (Puglia Region, Italy), by the end of March 2026.

#### **5. MODALITIES FOR SUBMITTING THE EXPRESSION OF INTEREST**

In order to express your interest in participating in the pilot action organized by the University of Foggia, it is necessary to fill out the form attached to this document.

The completed form must be sent to the University of Foggia by 29<sup>th</sup> January 2026 at 19:00, via e-mail to [piervito.bianchi@unifg.it], specifying in the subject line "**ECOFOODCYCLE project - Expression of interest for participation in the pilot action of University of Foggia**". A photocopy of a valid identity document of the signatory must be attached to the application form.

#### **6. MODALITIES FOR SELECTING PARTICIPATING BUSINESSES**

One business will be selected based on the following criteria:

##### **1. Relevance and motivation - Max. 7 points**

Clarity and coherence in explaining how the applicant intends to contribute to the implementation of the pilot action, based on the general concept outlined in this document.

##### **2. Feasibility and operational capacity - Max. 8 points**

Demonstrated capacity to support the logistics and implementation of the pilot action within the timeframe and scope defined by the project.

##### **3. Innovative potential and added value - Max. 8 points**

Potential of the proposed contribution to strengthen or complement the objectives of the pilot action, including added value in terms of communication, consumer engagement, or sustainability.

##### **4. Commitment to the project objectives - Max. 7 points**

Willingness to collaborate closely with the University of Foggia and to engage in awareness-raising actions connected to food waste prevention.

Applications will be evaluated and awarded a maximum of 30 points by a selection committee composed of 3 members from the Department of Economics of the University of Foggia. The



committee will assess all applications received by the deadline and select the candidates deemed most suitable in line with the criteria above.

## 7. PRIVACY PROTECTION
