ADMISSION PROCEDURES:	
The selection will be based on the <u>assessment of qualifications, written and oral tests</u> The written examination will test: the ability to understand a legal text; think about the same in order to detect the main problematic issues and the development of the legal argument as well as assess the coherence and completeness of the latter. During the oral exam the knowledge of the English language will be ascertained. The assessment will take place pursuant to art. no. 6 and 7 of the Call. Foreign candidates can choose to take the admission test in English.
