ADMISSION PROCEDURES:

The selection will be based on the assessment of qualifications, research project (according to the Format 1/H) and oral exam.

The research project, written in English and not exceeding a total of 3,000 words, must include the following sections: 1. *Purpose*; 2. *Originality/Value of the research project*; 3. *Design/Methodological Approach*; 4. *Expected Findings*; 5. *Implications*.

The assessment will take place pursuant to art. no. 6 and 7 of the Call.

ADMISSION TEST CALENDAR AND VENUE:

Publication of the list of candidates admitted to the oral examination (Art. 7, Paragraph 4):
September 24, 2026

Date: The test (oral interview) will be held on **September 28, 2026**.

Mode: The oral examination will be held **in person and conducted in English**, in order to also assess the candidate's level of proficiency in the language. The research proposal attached by the candidate to the application for admission to the selection procedure will be presented and evaluated during the oral examination. Furthermore, upon request of the individual candidate, the oral examination may be conducted in Italian, in which case the candidate's knowledge of the English language will be assessed at the end of the interview.

For candidates who request it, the interview may also be conducted online via compatible platforms, in accordance with Article 6 of the Call for Applications.
